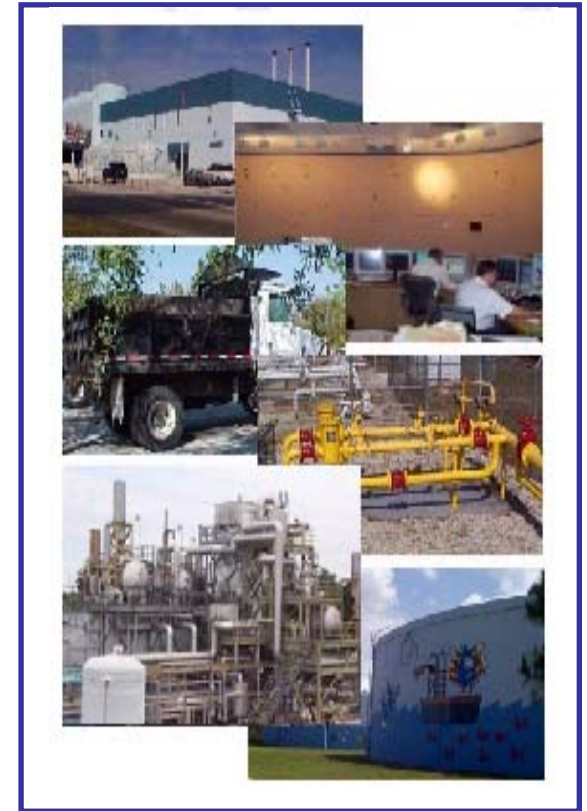

RCID / RCES Relationship

Established in 1967, Reedy Creek Improvement District (RCID), is the regulating authority for the *Walt Disney World* Resort and the cities of Lake Buena Vista and Bay Lake. It provides and supervises public services, such as utilities, drainage, waste collection, fire protection, flood control, pest management, land use planning and enforcement of building codes.

Reedy Creek Energy Services (RCES) is part of *Walt Disney World Co.* RCES is contracted by RCID to plan, design, operate and maintain the utility systems owned by the District. These systems include wastewater collection, treatment and disposal; central heating and cooling; electric transmission and distribution; potable and reclaimed water; natural gas transmission and distribution; drainage; road repair and solid waste collection, disposal and recycling.

RCES is also responsible for the operation and maintenance of the landfill and compressed air system, which are owned by the Walt Disney Co.

ENERGY CONTROL CENTER

The Energy Control Center is our communications center where all utility systems emergency dispatch and statewide electric system reliability coordination occurs. It is staffed 24 hours a day, 7 days a week, by a North American Energy Reliability Council (NERC) – certified utility systems operator.
